## DIRECTIONS TO TRIAL SITE

**From East or West:** take I-70 to Exit 131 St. Charles Rd/Lake of the Woods Rd. Turn S onto St. Charles Rd (0.1 mile). Turn R onto I-70 Drive SE. Stay on I-70 Drive SE for 0.9 mile. CCSC is on the left.

**From North or South:** take highway 63 to the I-70 interchange. Merge onto I-70 East and drive to Exit 131 St. Charles Rd/Lake of the Woods Rd. Turn S onto St. Charles Rd (0.1 mile). Turn R onto I-70 Drive SE. Stay on I-70 Drive SE for 0.9 mile. CCSC is on the left.



## TEST INFORMATION -NOTICE TO EXHIBITORS

- **THE TEST SITE** will be open at 8:00 AM
- **CHECK-IN:** 8:15 AM–8:45 AM
- **HANDLER BRIEFING:** 8:45 AM
- Exhibitors may bring their dog's **SCOREBOOK** with them to the test. Results are recorded in the **SCOREBOOK**. However, this is not necessary to participate in the ORT.
- **SPECTATORS ARE PERMITTED** during the ORT but must follow NACSW rules.

**ENTRIES:** TELEPHONE, FAX, UNSIGNED ENTRIES, AND ENTRIES RECEIVED WITHOUT FEES cannot be accepted. RETURNED CHECKS do not constitute a valid entry fee. A charge of \$25.00 will be made for each returned check. ENTRIES MUST BE MADE ON THE ATTACHED ENTRY FORM. NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE. OWNERS are responsible for errors in making out entry forms. EXPRESS MAIL entries must include a signature permitting them to be left at the secretary's address without recipient's signature.

**Entry Fee and Second Dog Policy** \$30.00 per dog. If entries do not fill by closing, we will allow a second dog per handler to be tested. Fill out a **second entry form and a separate check for the second dog**. You will be contacted on 21 August 2018 if we can accommodate your second dog. If your second dog can't be tested your check will be shredded.

**DOGS PRESENT** will not be permitted to roam. Exhibitors are responsible for the behavior of their dogs. The owner of each dog is solely responsible for being ready when it is time to be judged. There is no inside crating at this test. Be prepared to keep your dog in your car when not being tested or on leash at all times.

**FEMALES IN SEASON** are allowed at this test site, but will be tested last. Please inform the Secretary or Host if your dog is in season.

**DOGS PARTICIPATING** in the ORT must be at least six months of age, must appear to be healthy on trial day, and should be current on all vaccinations required by law.

**ACKNOWLEDGEMENT OF ENTRY ACCEPTANCE/CONFIRMATION** will be made when entries are processed for those handlers that provide an email address. If you require a confirmation via USPS, you must provide a self-addressed stamped envelope with your entry.
